

# Chairman's Statement



I have pleasure in presenting, on behalf of the Court of Governors, the Fifty-Fourth Annual Report and Audited Statement of Accounts of the Administrative Staff College of India (ASCI), for the year ending 31 March 2011.

The last year has been a good year for the College in terms of financial results. In the year ending

March 2011, the net surplus (after providing for depreciation and accounting for prior period adjustments) amounted to Rs. 108 lakhs, which represents a sharp increase over the previous year's figure of Rs. 38 lakhs. This increase in surplus was almost entirely on account of the rise in the operating income even as we have been successful in containing the operating expenditure. The rise in the operating income is almost entirely in the area of what one might call earned income as distinct from investment income. The earned income represents the contribution of programmes in management development and significantly higher income from management consultancy and research.

The income earned from management development programmes in 2010-11 was Rs. 1,810 lakhs; and that from the Post-Graduate Diploma in Hospital Management was Rs. 142 lakhs. Both these were significantly higher than what was recorded in the previous year. Programmes in the areas of General Management (Rs. 665 lakhs), Human Resources (Rs. 384 lakhs) and Operations (Rs. 269 lakhs) contributed significantly to the income from management development programmes. Overall, the College conducted 199 programmes with 4,213 participants, including 241 participants from abroad (foreign nationals and those representing international institutions) and 439 women participants. The participant profile remains more or less the same as in previous years with 46 per cent being from the Government sector, 35 per cent from the public sector, a little under 10 per cent from the private sector; 9 per cent from banks, both public and private; and about 6 per cent from abroad. It continues to be our endeavour to increase the proportion of participants from the private and corporate sectors.

During the period under review, in keeping with the objective of extending management development training to women, the College successfully conducted six programmes exclusively for women that attracted 97 participants. Eight new programmes were introduced in 2010–11. The College continues to explore new areas of management development activity and, in the year under review, it conducted programmes on such new themes as Environmental Regulations & Tools for Development Projects, Environmental Impact Assessment-Good Practices; Financing in the Social Sector; Public-Private Partnerships in the Social Sector; Marketing of Services, Productivity Management for Enhanced Organizational Competitiveness: Corporate Social Responsibility & Social Audit; and Benchmarking Urban Services.

The College continues to make progress in its Programme of Post-Graduate Diploma in Hospital Management (PGDHM). This Programme has been recognized by the AICTE; and, in the year under review, there were two batches of 29 and 30 participants, respectively. The participant profile has a significant proportion of graduates from the medical sciences. In the short period of its existence, the PGDHM offered by ASCI has established itself in the client community—an indication of this is that several hospitals have come forward with placements for the graduates of this course.

The progress in the management development programmes of the College has been the result of the faculty's commitment towards conducting good quality programmes and its initiative to offer new programmes of interest to industry and Government. The faculty has also been actively engaged in conducting research and management studies, which has helped to give the management development programmes a measure of practical relevance and fresh insights.

The College continues to expand its reach by seeking new areas of activity in management development. An important step here would be the proposed introduction of a one-year Executive Development Programme for middle-level managers. In organizing this Programme, the College will have the collaboration of the Pennsylvania State University, USA. Preparatory work for this Programme is underway, and it is hoped that the Programme could begin during 2012. The institution of this Programme would represent a major addition to the activities of the College.

The growth in activity in research and management studies is particularly gratifying. The College has established itself as an important centre for the provision of management research activity in urban and related sectors. During the year, the College received 63 new projects on research and management studies (as against 41 in 2009-10), with a combined value of Rs. 1,573 lakhs (as against Rs. 831 lakhs in 2009-10). Of these, research assignments accounted for Rs. 628 lakhs; and management studies accounted for Rs. 945 lakhs. As in the past, the Centre for Energy, Environment, Urban Governance and Infrastructure Development accounted for a major share, bagging 48 projects of the total R&MS activity. The other centres, among them the Centre for Management Studies and the Centre for Innovation and Technology, also contributed to the research and management studies conducted by the College during 2010-11.

The College successfully completed 45 projects—12 research assignments and 33 management studies—as compared to 54 in the previous year, comprising 15 research projects and 39 management studies. ASCI has initiated measures to evaluate the impact on the client organizations of its research and management studies. Management studies and research studies contributed Rs. 806 lakhs and Rs. 376 lakhs, respectively, to the income of the College. Details are provided in the relevant sections of the chapter on "Academic Activities"

Several important assignments were awarded to the College, reflecting the diversity of subjects handled by ASCI. These included: Study to Design a Roadmap for Establishing the Post Bank of India; Trade in Health and Hospital Services; Terminal Evaluation of the Five-Year UNDP Supported Project for the Operationalization of MGNREGA; Power Needs to Meet Uninterrupted Power Supply in Andhra Pradesh: A Road Map; Geo-spatial

Analysis of Climate Change—Impact on Agriculture in Different Agro-Climatic Regions in Andhra Pradesh; Indo-US Collaborative Project on Climate Research; Appraisal of Reforms under Jawaharlal Nehru National Urban Renewal Mission (Andhra Pradesh, Maharashtra & Goa); Developing City Sanitation Plans for Eight City Corporations of Karnataka State under the National Urban Sanitation Plan; Peer Experience and Reflective Learning (PEARL) Project—Setting Up of an Urban Help Desk for JNNURM Cities; Preparation of State Urban Housing and Habitat Policy and State Level Action Plans; National Urban Water Awards 2010; Study on Evaluation and Assessment of the Energy Efficiency Efforts by Hyderabad Metropolitan Development Authority; Academy for Science Policy Implementation & Research; Cognitive Factors, Emotional Intelligence & Effective Leadership in Scientists; Assessment of the Enabling Parameters of the Scheme for PM's Trophy for the Best Steel Plant in the Country, 2009–10.

Andhra Pradesh, Karnataka, Kerala, Maharashtra, Gujarat, Delhi, Haryana, Uttar Pradesh, Bihar, Chhattisgarh, West Bengal and Meghalaya, were among the states from whom projects were secured by the College. Many assignments were also secured from departments, ministries and agencies under the Union Government, such as Urban Development, Environment & Forests, Administrative Reforms & Public Grievances, Power, Steel, Posts, Defence, Cooperative Banks, and Science & Technology. International institutions that awarded prestigious projects to the College include: Department for International Development (DfID), Govt. of UK, the European Union, German Development Cooperation (GTZ), UNDP and Japan International Cooperation Agency (JICA).

For the fifth consecutive year, ASCI continued to work with the Dept. of Administrative Reforms & Public Grievances (DARPG), Govt. of India, in providing inputs for the prestigious Prime Minister's Awards for Excellence in Public Administration. The College assisted DARPG in carrying out scrutiny, evaluation as well as spot studies of the nominations received under the scheme. ASCI was a member of a panel of judges that selected the best steel plant in the country for award of the Prime Minister's Trophy for the Best Steel Plant in India.

In line with the Vision Committee's recommendations that greater salience be given to work on good governance, poverty studies, rural development and

human development, ASCI has been directing its attention to building capacities and achieving results in these key areas.

During 2010–11, four new faculty members were recruited, one member retired and six left the College. The faculty strength at end-March 2011 was 37. In recruiting new faculty, ASCI has looked for younger professionals and has had a measure of success in reducing the age profile of its faculty. Two new Honorary Advisors and one Adjunct Faculty joined the College during the year. The chapter on "Governance of the College" and Annexure 3 provide the details.

As in earlier years, the College continues to conduct seminars/workshops on issues of topical interest. On 28–29 January 2011, the College organized a National Seminar on Weather Insurance: Addressing the Risk Mitigation Needs of Weather-Sensitive Industries, led by the Centre for Poverty Studies & Rural Development, ASCI, and sponsored by NABARD, Agriculture Insurance Company of India Ltd. and State Bank of Hyderabad.

On 11–12 February 2011, ASCI held a two-day Retreat for Heads of Training Institutions across India, sponsored by the Dept of Personnel & Training, Govt. of India.

As in the past, the College continues to organize public and memorial lectures. Among the more notable events in this area were the Mohan Kumaramangalam Memorial Lecture on "The Real Purpose of an Industrial Enterprise", delivered by Mr. B. Muthuraman, Vice Chairman, Tata Steel Ltd. The Rajiv Gandhi Memorial Lecture on "Conflict Resolution in Contemporary India: Where Are We Heading?" was delivered by Mr. R. D. Pradhan, IAS, former Governor, Arunachal Pradesh, ex-Chairman, SICOM Ltd. Four public lectures by eminent personalities (details are available in Annexure 7) were also organized by the College, including the ASCI Foundation Day Lecture on "Recent International Financial Turmoil and Its Implications for Developing Countries" by Dr. Y. Venugopal Reddy, former Governor, Reserve Bank of India and Emeritus Professor, University of Hyderabad.

During 2010–11, the General Body of the College Society met once, the Court of Governors (CoG) thrice and the Standing Committee of the CoG on four occasions. The College continues to receive valuable guidance and direction from its distinguished Court of

Governors on various aspects of its activities, the development of infrastructure and its investments.

The College continues to add to or improve its infrastructure. The construction of a new campus at the College Park is proceeding apace and is expected to be completed by the end of this calendar year; and we hope to commence operations from this campus in the year commencing April 2012. This construction and related expenditure (interiors, furnishing, etc.) have been financed to a large extent by the interest-free loan of Rs. 5 crores, which the College received from the Government of India, supplemented by some of College's own resources. I would like to take this opportunity to express the deep appreciation of the College to the Government of India for its timely assistance.

I am happy to record that the College continues to enjoy the cooperation and support of the Government of India, state governments, industry and international organizations.

A significant development during the year was the establishment of a Centre for Innovations in Public Systems (CIPS), as a fully autonomous Centre, under the broad aegis of the Administrative Staff College of India. CIPS has been set up on the basis of the recommendation of the Thirteenth Finance Commission of India, which provided also for a grant of Rs. 20 crores from the Government of India, through the Andhra Pradesh Government, for a period of five years. The mission of CIPS is to help create a climate and nurture a culture for accelerating and diffusing innovations in public systems. The work programme of CIPS is defined by an Advisory Council consisting of representatives of the Government of India and all the state governments and union territories and a few independent experts. Being a fully autonomous institution, the accounts of CIPS will be kept distinct from those of ASCI. They will be audited annually and placed before the Advisory Council of CIPS, which, in turn, is expected to forward the accounts to the Court of Governors of ASCI. The establishment of CIPS as an autonomous Centre at the College reflects the trust placed in ASCI in promoting good governance.

Since its establishment, a number of workshops and seminars were held during 2010–11 on the delivery of services that matter to the citizen, such as health and education, urban governance and e-governance. CIPS is also disseminating knowledge on good practices and

innovations apart from making available technical assistance to carry forward innovations.

Looking ahead, I believe the College will continue to maintain its tempo of activity. As indicated in the earlier paragraphs, ASCI has been reinforcing its existing capacities and building new ones by recruiting new faculty and undertaking a wider range of programmes and studies. Steps are being taken to further enhance its international reach.

As an institution of national importance, working in the area of enhancing the professional quality of management in Government and industry, ASCI looks forward to its continuing relevance and service to the nation

The progress of the College during 2010–11, as in earlier years, could not have taken place without the involvement and continued dedicated efforts put in by the Director-General and his team of faculty, officers in administration and staff at all levels. I extend my warm commendation to all of them for their efforts.

# **Academic Activities**

#### A. Research and Management Studies

In the past few years, the Administrative Staff College of India has been focusing on areas of current concern and topical interest to industry and Government. This is in line with the recommendations of the Vision Committee. The research and management studies undertaken by the College continue to be predominantly action-oriented and are aimed at capacity building.

#### **New Assignments**

As in the past, the year under review witnessed the diversity of themes covered by various projects in functional as well as sectoral areas. They include: energy, urban infrastructure, corporate governance, reforms, service delivery, regulatory issues, risk management, health studies, work culture, technology management and human resource development. The sizeable number of assignments received in these diverse sectors is testimony to the varied capabilities of the College. ASCI has effectively leveraged the skills, expertise and experience of its faculty to carry out successfully current assignments and attract new ones.

During 2010–11, the College received 63 new assignments for research and management studies (see Table 1) valued at Rs. 1,573 lakhs. Of these, research studies accounted for Rs. 628 lakhs; and management studies accounted for Rs. 945 lakhs.

International institutions that awarded prestigious contracts to the College include: the Department for International Development (DfID), Govt. of UK, the European Union, German Development Cooperation (GTZ), United Nations Development Programme (UNDP) and Japan International Cooperation Agency (JICA).

ASCI continued to work with the Dept. of Administrative Reforms & Public Grievances (DARPG), Govt. of India, in assisting with the processing of applications for the prestigious Prime Minister's Awards for Excellence in Public Administration. The College assisted DARPG in carrying out scrutiny, evaluation as well as spot studies of the nominations received under the scheme. ASCI was a member of a panel of judges that selected the best steel plant in the country for the award of the Prime Minister's Trophy for the Best Steel Plant in India.

#### **Assignments Carried Over**

A total of 74 research and management studies (22 research projects and 52 consultancy projects) were carried over from the previous financial year to 2010–11 (see Annexure 6-A for a complete list of projects that were carried over and the respective organizations/agencies that awarded them). Table 2 gives the centre-wise break-up of the number of assignments carried over.

#### **Assignments Completed**

The College successfully completed 45 projects (12 pertaining to research studies and 33 to management studies) during the year as compared to 54 in the previous year (comprising 15 research studies and 39 management studies). #### **Income Earned**

The income earned from research and management studies during the year amounted to Rs. 1,182.25 lakhs. The break-up for 2009-10 and 2010-11 is given in Table 4 below.

This represents an increase of 19.71 per cent in project income during 2010–11.

#### **Assignments Carried Forward**

Eighty-seven research and management studies from 2010–11 were carried forward to the financial year 2011–12. Of these, research studies accounted for 26 projects and management studies accounted for 61 projects.

Further, during the year under review, ASCI was active in submitting many proposals for undertaking advisory and technical projects and providing contract research and management services in several focus areas. It is envisaged that these will translate into contracts in the course of 2011–12.

#### **B.** Management Development Programmes

ASCI continues to conduct training programmes to meet the needs of Government, public sector undertakings and private corporations. In the area of general management, the College continues to deliver management development programmes (MDPs) in several disciplines, such as Human Resource Management, Organization Behaivour, Operations Management, Strategic Management, Marketing, Economics and Finance, Poverty Studies and Rural Development, Weather Insurance, Water and Sanitation, Environment, Natural Resources Management, Urban Governance, Power, Energy, Infrastructure Management, Gender Facilitation and Budgeting, Public Health, Public Policy, Innovation, Information Technology, Science and Technology Management, and Health Care Management.

The College's flagship programmes—the Advanced Management Programme and the General Management Programme for Senior Executives—continue to offer training for senior officers and executives in Government, industry and business. The customized organization-specific programmes, sponsored by governments and industry, in the core areas of ASCI, contribute to the strengthening of management capacities of the country. ASCI conducts the long-duration programme on Post-Graduate Diploma in Hospital Management, aimed at enhancing the managerial and administrative capacities of health-care professionals in the country.

The College conducted close to 200 MDPs during 2010–11. The total earned income from MDPs, other than from the Post-Graduate Diploma in Hospital Management (PGDHM) programme, during the year was Rs. 1,810 lakhs (a 4.98 per cent increase over the 2009–10). The income earned from the PGDHM programme during 2010–11 was Rs. 142.34 lakhs. The contribution of each of the three categories of MDPs to programme income is shown in Table 5 (see Annexure 4 for a complete listing of the programmes).

Faculty members initiated new announced programmes of interest to academia, governments and industry. An increase in income from all the three categories of programmes, with a substantial contribution by the incompany on-campus and announced programmes, resulted in enhanced MDP revenues for the College.

As can be seen from Table 6, of the 199 programmes conducted during 2010–11, 72 were announced programmes (compared to 67 in the previous year). The number of in-company on-campus programmes also increased marginally, while the number of in-company off-campus programmes increased by more than 47 per cent (Tables 8, 9 and 10, respectively, provide an areawise break-up of these three categories of programmes, with details of participation).

The sector-wise break-up, shown in Table 7, indicates that participation from the public and private sectors increased during the year under review.

ASCI continues to make strides in delivering quality management development programmes for the government, public sector undertakings and private corporations. The announced programmes are primarily targeted at the public sector, and it is expected that the faculty will take new initiatives to expand its footprint in this important business sector. ASCI will continue its long-standing relationship with government departments and public sector undertakings.

The PGDHM programme is gaining salience with the diploma holders securing good placements, which bodes well for their future careers.

# **Activities of the Centres**

The management development programmes (MDPs) conducted by the various centres of the College and the research and management studies carried out by the different areas within the centres are delineated in the sections below. Details of the faculty members who directed the MDPs referred to and conducted the studies mentioned are provided in Annexure 4 and Annexures 6-A to 6-C, respectively.

# I. Centre for Public Policy, Governance and Performance

#### Research & Management Studies

#### **New Projects**

- awarded during 2009–10, was completed during the year. The report was well received.
- Study to Design a Roadmap for Establishing the Post Bank of India (PBI): Sponsored by Dept. of Posts, MC&IT, GoI. The study, which was jointly conducted with and led by faculty from the Economics area (awarded to the area during 2010–11), was nearing completion at the close of the year under review.

# II. Centre for Poverty Studies and Rural Development

#### **Management Development Programmes**

The efforts initiated by the Centre for Poverty Studies and Rural Development (CPSRD) in recent years for evaluation of resettlement & rehabilitation (R&R) policies and programmes of various state governments and public sector enterprises (PSEs) in the country has generated much demand for capacity building of managerial personnel on various aspects of R&R. CPSRD organized a three-day programme on Resettlement and Rehabilitation for the Executives of NTPC Ltd. in June 2010, which was followed by a one-week programme on Building a Vibrant Stakeholder Environment for the Executives of NHDC (formerly known as Narmada Hydroelectric Development Corporation), with broader content, in October 2010. Combining the perspectives on R&R with the compulsions for corporates to create and sustain a vibrant stakeholder environment, a more customized management development programme (MDP) was organized for the middle- and senior-level executives of NHPC (formerly known as National Hydroelectric Power Corporation) Ltd. in March 2011. In developing these customized MDPs for large PSEs confronted with stakeholder management challenges, CPSRD has established itself as their resource partner.

Following the positive feedback received from the participants of the off-campus MDP for Small & Medium Enterprises (SMEs) of the Pacific Region conducted in 2009, the Commonwealth Secretariat (ComSec), London, the Centre for the Development of Enterprise (CDE), Brussels, of the European Union, and Pacific Capital Partners (PCP), Brisbane, jointly sponsored

another session of the MDP, which was held during 25-29 October 2010 at Port Moresby (POM) in Papua New Guinea (PNG). Participants from small and medium enterprises (SMEs) based in PNG, Fiji, Vanuatu and Tonga were nominated to participate in the programme, which was delivered in collaboration with the Institute of Business Studies (IBS), POM. With these two MDPs, CPSRD has deepened its partnership with the SME sector in the Pacific region. The Commonwealth Secretariat is now contemplating a study on training needs analysis (TNA) to make future MDPs more customized to the learning and management development needs of enterprises in the island economies of the Pacific region. Stronger partnerships with local management development institutions are also envisaged, as part of the Commonwealth Private Investment Initiative.

Though uncertainty of crop yields of varying magnitudes is one of the basic risks faced by agriculturalists worldwide, this is particularly high in India on account of the extreme dependence of our farm sector on weather conditions. Among the direct and indirect measures taken by the Government of India (GoI) to mitigate production and price risks, the Agricultural Insurance Scheme (AIC) has been an important policy initiative. With a view to strengthening AIC and making risk management systems more objective, index-based weather risk insurance contracts in agriculture have emerged as an important risk mitigation tool. To discuss the prospects and challenges in implementing the weather-based group insurance scheme on a larger scale in India, a national seminar was organized by CPSRD on 28-29 January 2011. A total of 90 delegates, including speakers and presenters, from public and private sector insurance agencies, academia, regulatory bodies, banks and civil society organizations participated in the seminar.

The Centre continues to forge strong linkages with other development institutions like the National Institute for Rural Development (NIRD), State Institutes of Rural Development, National Institute for Micro, Small and Medium Enterprises (NIMSME), Dr. Marri Channa Reddy Human Resource Development Institute (MCRHRDI), Institute of Public Enterprise (IPE), and the Jawaharlal Nehru Institute of Development Banking (JNIDB) to promote institutional capacities for strengthening rural governance, development leadership and the SME sector with a view to alleviating rural poverty. Besides participating in the committees for selection and

development of faculty resources, CPSRD has been invited to contribute resource inputs to various development management programmes and conferences organized by these institutions for the functionaries of the corporate sector, state governments and the Gol. A presentation was also made at the National Dialogue on Building Leadership in Agricultural Research Management: Concerns and Future Strategy, organized by the National Academy for Agricultural Research Management (NAARM) on 27–28 August 2010.

#### Research and Management Studies

As an active member of the Professional Institutional Network (PIN) constituted by the Ministry of Rural Development (MoRD), Govt. of India (GoI), under the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA), CPSRD has been making a significant contribution to the programme implementation and its reform from time to time. Represented on the Committee for Selection of Ombudsmen under MGNREGA in the state of Assam, CPSRD has participated in two meetings of the selection committee chaired by the Chief Secretary to the Govt. of Assam for the selection of ombudsmen in most districts of the state. Besides being represented on the Expert Committee for the development of research methodologies for various monitoring and evaluation studies on MGNREGA, CPSRD has also been invited to join the expert group for selection and monitoring of the performance of national-level monitors (NLMs), who have been assigned a critical role by MoRD for monitoring all the rural development programmes in the country.

Further, a study on Terminal Evaluation of the Five-Year UNDP Supported Project for the Operationalization of MGNREGA was awarded to CPSRD, jointly by MoRD and UNDP. The study will be carried out across a sample of five states—Rajasthan, Madhya Pradesh, Orissa, Tamil Nadu and Andhra Pradesh—with a focus on the selected interventions that were implemented under the abovementioned project. CPSRD has also contributed actively to the work of the Expert Committee on the selection of awardees for outstanding performance and innovation in the implementation of MGNREGA in 2009–10. The Committee short-listed 16 out of the 55 districts that made initial presentations in New Delhi; all the 16 districts were visited by different members of the committee for field assessment. CPSRD was involved in the field assessment made in the states of Karnataka, Tamil Nadu, Madhya Pradesh and Manipur. The work of the Expert Committee was appreciated by the MoRD at the ceremony held on 2 February 2011 for distribution of awards at the hands of the Prime Minister of India.

Two studies commissioned by the Government of Nagaland (GoN) during 2008–09 for Preparing Recovery and Corporate Plans for the Nagaland Industrial Development Corporation (NIDC) and the Nagaland Handlooms and Handicrafts Development Corporation (NHHDC) achieved closure during the year with the acceptance of the final reports submitted by CPSRD. The impact of these studies will be experienced by both the state-level public enterprises (SLPEs) of the GoN in the long term as the recovery packages recommended for their repositioning are implemented. The GoN is expected to approach relevant ministries and institutions of the Govt. of India for assistance in taking forward the recommendations made by CPSRD.

The study awarded in 2009–10 by the Dept. of Land Resources (DoLR), MoRD, GoI, for developing the Programme Management Unit (PMU) to facilitate the National Land Records Modernization Programme was nearing completion at the close of the year under review. CPSRD made two presentations, one each to the former and the present Secretary of DoLR. The impact of the study is expected to be valuable to the DoLR as the proposed PMU is likely to play a much wider role beyond the original mandate, in catalyzing policy and programme implementation in the management of land resources.

#### III. Centre for Human Development

The Centre for Human Development (CHD) comprises three areas: Health Studies, Education Studies and Gender Studies. All the three areas of social development are critical to the achievement of the global Millennium Development Goals.

During 2010–11, the CHD faculty was selected to be part of an independent national team that undertook Assessment of Development Results of UNDP's India Country Programmes over the past five years.

The CHD team contributed to Teaching Evaluation in South Asia (TESA)—an initiative sponsored by International Development Research Centre (IDRC), Canada—aimed at developing, establishing and institutionalizing evaluation teaching in premier academic institutions in South Asia. ASCI is part of a consortium

of South Asian universities specially constituted for developing, establishing and institutionalizing teaching evaluations in South Asia. Faculty members participated in several meetings in Colombo and New Delhi and developed modules as part of the curriculum development initiative. In particular, CHD developed a module on Introduction to Evaluation and Qualitative Methods for the consortium, which will also be used in the programmes that the College will conduct in the field of evaluations.

#### **Health Area**

#### Research and Management Studies

The Health Studies area received an additional project under ASCI's partnership in the DFID-funded, Family Health International-led project on Andhra Pradesh Health Sector Reform Programme for the period September 2008–August 2010. The project envisages providing technical assistance to the Dept. of Health, Medical and Family Welfare, Govt. of Andhra Pradesh, to undertake a major overhaul of the public health sector so as to improve health service delivery to the rural and poor segments of the state. ASCI's role in this project has been to support a process consultancy, which includes training and capacity building, procurement and some financial management. With the help of a consultant, the project was completed by August 2010.

The Health Studies area was awarded a study in 2010–11 on Support to Dept. of Health and Family Welfare (DH&FW), Govt. of Madhya Pradesh (GoMP), for a Rapid Review and Expanded Scope of State Illness Assistance Fund, sponsored by DH&FW, GoMP. The study was underway during the year.

The study on Concurrent Evaluation of the National Rural Health Mission (NRHM)—Andhra Pradesh, sponsored by the Ministry of Health and Family Welfare, Govt. of India, and awarded during 2008–09, was underway during the year under review.

A faculty member of the Health area presented a paper on "Successful Resettlement: An Imperative—Experiences from Orissa" at a National Seminar on Impoverishment Versus Reconstruction in Development-Induced Displacement: Approaches and Issues at the Council for Social Development, Hyderabad, sponsored by ICSSR on 18–19 February 2011. He also presented

a paper on "Finalization of Qualitative Tools: Use of Ethnography Method in the HIV Sector" at a one-day meeting held at Hindustan Latex Family Planning Promotion Trust, New Delhi, on 11 January 2011.

A faculty member of the Health area presented papers at two international conferences. The paper "Willingness to Pay for Health Insurance: A Study from Kerala in South India" was presented at the International Conference on Urban Health held in New York City on 26–29 October 2010 and organized by the International Society for Urban Health. The paper titled "Public-Private Partnerships in the Health Sector" was presented at the International Conference on Poverty, held in Mumbai on 7–8 February 2011 and organized by the Tata Institute of Social Studies (TISS) and Creative Handicrafts.

The Health area was engaged in several customized management development programmes (MDPs). These included:

- Hospital Operations Management for the District Coordinators of Health Services of APVVP Hospitals: 23–28 August 2010 (27 participants). Sponsored by Andhra Pradesh Vaidya Vidhana Parishad (APVVP), Govt. of AP.

- Retreat for Heads of Training Institutions across India: 11–12 February 2011 (14 participants).

#### Gender Area

#### Management Development Programmes

The Gender Studies area faculty have been involved in directing their own management development programmes (MDPs) as well as contributing modules in the training programmes conducted by other areas of the College for scientists, government officials, and the public and private sectors.

The following MDPs directed were conducted by the Gender Studies area during the year:

- Gender, Governance and Leadership for Senior Officials of Ministry of Women's Affairs, Govt. of Afghanistan: 19–28 April 2010 (13 participants). Sponsored by The Asia Foundation, Kabul.
- General Management Programme for Senior Scientists: 17–28 May 2010 (28 participants).
   Sponsored by the Dept. of Science and Technology (DST), Govt. of India (GoI). The programme was co-directed with faculty from the Information Technology area.
- Gender Budgeting for Executives of Oil India Ltd., Duliajan: 24-25 November 2010 (22 participants). Sponsored by Oil India Ltd., Duliajan, Assam.
- Advanced Techno-Management Programme for Middle Level Scientists: 3 January-4 February 2011 (16 participants). Sponsored by DST, Gol. The programme was co-directed with faculty from the Marketing area.
- Gender Budgeting and Planning: Practices for Equity and Accountability: 24–26 January 2011 (7 participants). This was a College-announced programme.
- Enabling Gender Inclusivity and Leadership for Women Managers: 10–12 March 2011 (5 participants). This too was a College-announced programme.
- Mission 10X Academic Leadership Workshop: 28–30 March 2011 (20 participants). This general management programme was sponsored by Wipro Ltd.
- Improving Governance for Better Development: Tools and Techniques: 21 March–1 April 2011

(20 participants). Sponsored by the Ministry of Finance, Govt. of Afghanistan.

The Gender Studies area organized a half-day seminar on Skilling Women for Work in the Informal Sector on 28 February 2011. The seminar was well-attended with participation from the National Institute of Rural Development, Osmania University, the Dept. of Women's Development, Govt. of Andhra Pradesh, NGOs and training institutes.

#### Research and Management Studies

Gender area faculty were involved in writing and presenting research papers. A faculty member presented a paper on "Feminist Research Methodology" at a workshop organized by Madras Institute of Development Studies and the Indian Association of Women's Studies Workshop (23–26 February 2010). A faculty member also attended a Training of Trainers Programme on Gender Budgeting at the Indian Institute of Public Administration, New Delhi, organized by the Ministry of Women and Child Development (MWCD), Govt. of India (30 June–1 July 2010).

The Gender area Chairperson was on leave from the College for six months (July-December 2010). During this period, she served as Research Fellow (July-September 2010), German Development Institute, Bonn, a think tank for BMZ, the Ministry for Development Cooperation, Govt. of Germany; and as Visiting Fellow (October-December 2010), Organization for Economic Cooperation and Development-Development Centre (OECD-DEV), Paris, a inter-governmental organization. Research work undertaken at OECD-DEV is under discussion with the Government of India for a larger project.

#### **Education Studies Area**

In 2008–09, UNICEF, Hyderabad, had awarded ASCI an advocacy project on Promoting Quality Education for Children Belonging to Tribal Communities in Andhra Pradesh. The final phase of the project was completed in August 2010.

#### IV. Centre for Economics and Finance

The Centre for Economics and Finance (CEF) has been involved in a number of management development programmes and research and management studies. Details for the two areas are provided below:

#### International Trade and Finance, Industry, Macro-Economic Policy and Public Finance Area

#### Management Development Programmes

The Economics area has been involved in training activities in terms of programme direction, module coordination as well as handling sessions in programmes for scientists, government officials and conducting general management programmes for the corporate sector. The details are provided below:

- New Tax Regime (GST and Direct Tax Code): 19– 21 July 2010 (16 participants). This was a Collegeannounced programme.
- Financial Systems, Management and Accountability in Government (held twice during the year): 16–20 August 2010 (19 participants) and 13–17 December 2010 (6 participants). This too was a College-announced programme.

- Current Economic Issues for ISS Officers & Senior Officers of States/UTs (held twice during the year): 20–24 September 2010 (15 participants) and 13–17 December 2010 (11 participants). Sponsored by the Ministry of Statistics and Programme Implementation, GoI, this was a new programme.
- General Management Programme for Middle Level Scientists: 27 September–8 October 2010 (24 participants). Sponsored by the Dept. of Science and Technology (DST), GoI, this was a new programme.
- General Management Programme for Middle-and Senior-Level Women Scientists: 22 November–3 December 2010 (27 participants). Sponsored by DST, Gol.

- Management Development Programme for Officers of the Geological Survey of India (GSI): 3–14 January 2011 (18 participants). Sponsored by GSI, Hyderabad. This programme was codirected with faculty from the Information Technology area.
- General Management Programme for Senior Executives Session 116: 10 January–4 February 2011 (24 participants). The programme was codirected with faculty from the Marketing area.

A faculty member from the Economics area initiated a course on Health Economics for the Post-Graduate Diploma in Hospital Management offered by ASCI, along with faculty from the Heath area.

Area colleagues have been involved in taking sessions in a number of programmes, including General Management Programme for Scientists, Advanced Management Programme, Financial System Management and Accountability in Government, Management Development Programme for ISRO, IFFCO, etc.

#### Research and Management Studies

The study on Developing a Revenue Forecasting Model, awarded during 2008–09 by the Govt. of Andhra Pradesh, was completed during the year under review. The study was jointly conducted with faculty from the Innovation area.

On a request from the Dept. of Commerce, Ministry of Commerce and Industry, Govt. of India, the Centre Director, along with colleagues from the Economics, Health and Information Technology areas, submitted an expression of interest in undertaking research on services in the context of the WTO negotiations in August 2010, which was followed by a presentation to the Department. The study on Trade in Health & Hospital Services was awarded to the College in January 2011. Abm. S. Narayanan, Advisor, ASCI, is an advisor to the project.

#### Impact of Research Study

CEF is advising the Ministry of Commerce, GoI, on the WTO negotiations pertaining to the health services sector under the project as described above.

# Money, Banking, Corporate Finance and Governance Area

#### Management Development Programmes

- General Management Programme for the Executives of Tamilnad Mercantile Bank (TMB): 26-31 July 2010 (15 participants): 9-14 August 2010 (15 participants).
- Corporate Governance Leadership for the Senior Executives of ONGC Ltd.: 6–8 September 2010 (24 participants).
- International Trade for Senior Executives of the State Trading Corporation of India Ltd.: 20–25 September 2010 (23 participants). The programme was the first of its kind to be held at ASCI and was successfully concluded.
- Management Audit: A Way Forward for Performance Improvement: 11–15 October 2010 (7 participants). This was a College-announced programme.

- Management Development Programme for the Executives of ONGC: 29 November-11 December 2010 (14 participants).

A faculty member from the Finance area began teaching a course on Financial Management to students of the PGDHM course. The course commenced in January 2011.

Dr. Lakshman Muddu joined ASCI in June 2010 as Associate Professor in the Finance area.

#### Research and Management Studies

- Corporate Governance Study: Sponsored by the Dept. of Public Enterprises, Govt. of Orissa, the study was awarded during 2007–08 and completed during the year under review. The study was jointly conducted with faculty from the Public Policy and Rural Development areas.
- Conference on Corporate Governance Reform for State-Level Public Enterprises (SLPEs) of Karnataka: Sponsored by National Foundation for Corporate Governance (NFCG), the project was awarded during 2009–10 and was completed during the year under review. The conference was jointly conducted with faculty from the Public Policy area.

A faculty member of the Finance area submitted a proposal to the Dept. of Posts, Ministry of Communications & Information Technology, Govt. of India, for setting up the Post Bank of India. The bid was successful, and the Study to Design a Roadmap for Establishing the Post Bank of India was awarded to the Finance area in October 2010. The study was jointly conducted with faculty from the Public Policy area. It was nearing completion at the close of the year under review.

#### V. Centre for Energy, Environment, Urban Governance and Infrastructure Development

The Centre for Energy, Environment, Urban Governance and Infrastructure Development (CEEUG&ID) conducted several management development programmes (MDPs) and research and management studies during the year (see Annexure 4 and Annexures 6-A to 6-C, respectively, for details on the titles, dates and the faculty involved).

The Urban Governance and Infrastructure Development (UG&ID) areas received several research assignments, including a prestigious study from the Ministry of Urban Development (MoUD), GoI, to undertake an appraisal of reforms implementation under the Jawaharlal Nehru National Urban Renewal Mission (JNNURM). The recommendations of the appraisal reports prepared by ASCI and the various capacity-building initiatives taken by the UG&ID areas are expected to take forward urban policy reforms at the national level and promote urban sector reforms in the lagging states of India. MoUD has appointed the College as the national technical support unit for operationalizing the 13th Finance Commission recommendations pertaining to urban issues across various states of India. The UG&ID areas have been providing support to major municipal corporations, urban local bodies and quasi-state agencies in policy formulation.

Poor sanitation is a major national concern, affecting the health and dignity of all. The UG&ID areas are committed to supporting cities in their efforts to prepare and implement sanitation improvement plans, with a view to making urban areas free from open defecation. ASCI is commissioned by the Urban Development Dept., Govt. of Karnataka, to extend advisory services for improving urban sanitation on a mission mode basis. The College will be hand holding eight cities of Karnataka in this regard. Similar work is being undertaken for seven cities of Uttar Pradesh and five towns of Andhra Pradesh. ASCI is playing a key role in advocating better sanitation in Indian cities, with some visible impact.

The Energy area received several research and management studies during the year. These included preparation and processing of tariff regulations for various state electricity regulatory commissions, quality and quantity inspection of power projects and schemes in AP, and conducting energy and account audits in Bihar State Electricity Board. An important assignment bagged

by the area was on Power Needs to Meet Uninterrupted Power Supply in Andhra Pradesh: A Road Map, awarded by the Federation of Andhra Pradesh Chambers of Commerce and Industry.

The Environment area bagged climate change research assignments from the Ministry of Environment and Forests (MoEF), GoI, and the US National Science Foundation, focusing on air quality modelling and climate modelling. The area was awarded a prestigious assignment on energy efficiency by ClimateWorks Foundation, San Francisco, along with National Resources Defense Council (NRDC), New York. The Environment area also received a study on evaluating the potential and analyzing the implications of the Clean Development Mechanism (CDM) and Biomethanation from MoEF, GoI.

The Centre carried over 52 research and management studies from 2009–10, received 48 new assignments, and completed 30 projects during the year under review.

During 2010–11, the CEEUG&ID organized several customized MDPs for specific clients, both on-campus and off-campus, apart from conducting College-announced programmes.

#### Invitation to the Director of CEEUG&ID

Prof. Srinivas Chary Vedala, Centre Director, was invited to join the following committees:

- As Member of the Steering Committee on Urban Development Management for the Formulation of the Twelfth Five-Year Plan (2012–17), under the Chairmanship of Mr. Arun Maira, Member, Planning Commission of India.
- As Member of the Expert Committee constituted under the Sub-Committee of the National Development Council on Urbanization Issues

#### VI. Centre for Innovation & Technology

The Centre for Innovation and Technology (CIT) has been expanding and deepening its activity profile in scale, scope and specialization.

#### **Management Development Programmes**

The Centre is increasingly making a mark in conducting programmes that revolve around the strategic use and

application of technology and management of innovation in the corporate and government sectors. Its activities are characterized by a diversity of programmes and the growing demand for them. Reputed organizations like the Defence Research and Development Organization (DRDO) and Dept. of Personnel and Training (DoPT), Govt. of India (Gol) are now part of the clientele list of the Centre, which comprises such respected names like DST, ISRO, HCL and ONGC.

The Centre for the first time designed and conducted a new programme for DRDO, namely, Emerging Issues for Success in a Knowledge-Based Environment for Middle and Senior Level Professionals (21 participants), held on 25–27 August 2010.

The success of the programme on Technology Valorization and Management for Scientists, conducted by CIT faculty during 31 January–11 February 2011, can be gauged from the fact that this programme was awarded to the College by the Dept. of Science & Technology (DST), GoI, for the fifth consecutive year.

A CIT faculty member directed the General Management Programme for Senior Executives, a College flagship programme. CIT faculty members were also very active in contributing to the general management and management development programmes offered by the College, accounting for a sizeable share of the training activity.

The Centre continues to play a leading role in its areaand theme-specific programmes for DST, GoI, such as technology commercialization, innovation management and innovation in public services.

Members of the Centre have also provided support to the Post-Graduate Diploma in Hospital Management (PGDHM) Programme, by offering (full-semester) courses in strategy and information technology.

The Director of CIT, in his additional role as the Coordinator of the Executive Development Programme, was involved in planning and bringing to fruition collaboration with overseas academic partners. ASCI signed a Letter of Intent with Penn State Harrisburg, an undergraduate college and graduate school of The Pennsylvania State University, USA, for conducting a one-year Executive Development Programme from 2011 at the College.

#### Research and Management Studies

The Centre for Innovation and Technology received a three-year project from DST, GoI, called Academy for Science Policy Implementation and Research (ASPIRE). This project will be incubated by ASCI in a programme mode and will be spun off as an institution.

The Centre received a prestigious project on Quality Audit of the Activities of SVPNPA from the Sardar Vallabbhai Patel National Police Academy (SVPNPA), Hyderabad.

CIT continues to be involved in the Euro-India Synchronization of Policy Initiatives and Research & Innovation Trajectory (Euro-India SPIRIT) project—an initiative funded by the European Commission Information Society and Media Directorate General, Brussels. The project aims at finding common ground and synergizing the policies of India and Europe in the information and communication technology (ICT) arena.

A three-day e-Governance Workshop for Senior Civil Services and Ministers of the Govt. of West Bengal was conducted in Kolkata during 6–8 July 2010.

The Centre continued to provide technical assistance to Mishra Dhatu Nigam Ltd. (Midhani), by way of enterprise resource planning (ERP) consultancy, monitoring and implementation management support. The additional project, which was awarded during 2009–10, moved into the stabilization phase during the year.

During the year, CIT successfully completed the prestigious task of providing inputs and assistance for implementing the Prime Minister's Awards for Excellence in Public Administration (PMAEPA) for 2008–09, awarded by the Dept. of Administrative Reforms and Public Grievances (DARPG), GoI. The Centre was awarded the task of implementing PMAEPA for 2009–10 as well. CIT has been leading this work for the fifth consecutive year, since the inception of the scheme, successfully meeting the stringent requirements of DARPG and retaining its confidence.

#### Other Activities

The Director of the Centre for Innovation and Technology was appointed as Acting Director for the newly set up Centre for Innovations in Public Systems (CIPS). Under the aegis of CIPS, several workshops and research activities were carried out during the year.

#### VII. Centre for Management Studies

The Centre for Management Studies (CMS) has continued to make significant contribution to the activities of the College during 2010–11. CMS undertook numerous management development programmes, and research and management assignments for addressing the needs of Government, public sector undertakings and private corporations. Through its areas—Human Resource Management, Marketing, Operations Management and Strategic Management—the Centre has designed and delivered several new initiatives in addition to delivering in its established domain. As in the past, the programmes conducted by CMS continued to attract a large number of foreign participants from across the globe.

# Mangement Development Programmes General Management Programmes

The Centre conducted several well-subscribed announced programmes during the year, including the General Management Programme for Senior Executives: Sessions 115 & 116, Advanced Management Programme, Programme for Young Managers, and Management Development Programme for Women Executives.

A number of customized in-company on-campus as well as off-campus general management programmes (GMPs) were offered. These include the Advanced Technomanagement Programme for Middle Level Scientists (DST) (conducted twice), General Management Programme for Senior Scientists (DST), Management Development Programme for the Principals/Faculty of IHMs/FCIs/IITTM and the Officers of the Ministry of Tourism (conducted twice), Management Development Programme for the Executive Trainees of NMDC (twice), General Management Programme for Tamilnadu Mercantile Bank (twice), Management Development Programme for Allahabad Bank (twice), Management Development Programme for the Officers of Central Warehousing Corporation, Management Development Programme for the Scientists of ISRO, Executive Development Programme for the Executives of NMDC, Retreat for Heads of Training Institutes across India (DoPT), Management Development Programme on International Trade and Finance for the Executives of State Trading Corporation, General Management Programme for the Senior Executives of IFFCO.

#### **Human Resources Area**

The announced programmes in Human Resources (HR) area included HR Audit, Communication Skills for Managers, Leadership through Self-Discovery, Leadership and Organization Development, Strategic Human Resource Management, Leadership Skills Development (conducted twice), Negotiation Skills, Personal Growth for Effective Leadership, Personality Development, Values-Driven Leadership, Leadership for Managing Change, Executive Coaching for Leadership Development, Managing Creativity and Innovation, Developing Emotionally Intelligent Leadership, Strategic Leadership, Leadership and Organization Development, Improving Work Culture, Team Building and Conflict Management, Personal Growth for Effective Leadership, Enhancing Managerial Effectiveness, Decision-Making for Effective Leadership, Managing Human Relations in Organizations, and Effective Trade Union Management.

Faculty belonging to the HR area also conducted several customized in-company on-campus as well as off-campus programmes. These included: Leadership Development Programme for AGMs of Bank of India, Human Resource Management (HRM) for Line Managers of Nuclear Power Corporation of India Ltd. (NPCIL) (conducted nine times), Managerial Effectiveness for Executives of HMT-Machine Tools Ltd. (twice), Vertical Interaction Course for IPS Officers: Image Building Behaviour Pattern of the Police for BPRD, High Performing Teams and Leadership Issues for Women Scientists for DST, Strategic Human Resource Management (SHRM) for NHPC, HRM for NPCIL Executives, SHRM for BEL, HRM for Line Managers of NHPC, Managing HR in Organizations for NHPC, Leadership Development Programme for the AGMs and DGMs of Punjab National Bank, Negotiation Skills for the Executives of NHPC, Personal Growth for Effective Leadership for Addl SPs/Dy SPs conducted for the Bureau of Police Research & Development (BPRD), Personal Excellence for Professional Development for Defence Research Technical Cardre (DRTC) Officers of Defense Research & Development Organization (DRDO) (conducted twice), Leadership Development Programme for the Newly Promoted AGMs of PNB (conducted twice), Interpersonal Relations and Competence for DRTC Officers of DRDO (conducted twice), Orientation Programme on Creativity Leadership for the Officials Oil and Natural Gas Corporation (conducted four times; off campus), Leadership and Organization Development for the Executives of Indian Overseas Bank, Training Programme on Group Discussion for HR Executives of Oil India Ltd., Effective Trade Union Management for the Executives of Zuari Industries, and Training the Trainers for the Employees of Ultra Tech Cement Ltd.

#### **Marketing Area**

The Marketing area conducted four announced programmes. These were Sales Management (twice), Marketing of Services, and Strategic Marketing. The area also conducted an in-company on-campus programme on International Trade for Senior Executives of State Trading Corporation of India Ltd.

#### **Operations Management Area**

The Operations Management area conducted announced programmes on Inventory Management, Procurement Procedures for World Bank-Aided Projects (thrice), Productivity Management for Enhanced Organizational Competitiveness, Project and Contract Management (twice), Materials and Supply Chain Management, and Project Management for World Bank-Aided Projects.

Operations area faculty conducted several customized in-company on-campus as well as off-campus programmes. These included: Science Administration & Research Management for DST (conducted twice), World Bank Procurement Procedures for Officials of National Cyclone Management Project, Govt of AP, Workshop on Lean Manufacturing for Senior Management Team Members of United Spirits Ltd., Interaction with Egyptian Government Officials, Project Management for Indian Statistical Services Officers, World Bank Procurement Procedures for Officials of Andhra Pradesh Rural Water Supply & Sanitation Project, Inventory Management, Supply Chain and Logistics for Executives of Bharat Dynamics Ltd. (conducted twice), Training Programme on Procurement for Maharashtra Agricultural Competitiveness Project, Procurement Procedures for the Officials of Orissa State National Cyclone Risk Management Project, Management Time Line & Cost for DLRL, and One-Day Workshop/Meeting for DST.

#### Strategic Management Area

The Strategic Management area conducted one announced programme on Corporate Social Responsibility & Social Audit. The area faculty also conducted an in-company programme on Management and Leadership for Women Officials of Govt. of Afghanistan, which was sponsored by Afghan Civil

Service Support-USAID Afghanistan, and Deloitte Consulting LLP, Afghanistan.

#### Research and Management (R&M) Studies

Besides conducting management development programmes, CMS faculty members with expertise in various functional areas of management are engaged in undertaking a number of research and management studies. The HR area completed four R&M assignments during 2010–11, of which three studies were received during the year; and two assignments received by the HR area during 2010–11 were underway. An R&M study received by the Operations area during the year was underway.

#### **ONGC Chair**

After a gap of a few years, the ONGC Chair instituted at the Centre for Management Studies was revived. Prof. Milind Phadtare was appointed as ONGC Chair Professor with effect from 1 September 2010.

#### VIII. Centre for Healthcare Management

The Centre for Healthcare Management (CHM) was established in August 2009 in order to enable the College to focus on the smooth conduct and further development of the two-year Post-Graduate Diploma in Hospital Management (PGDHM) Programme. The Programme, which has been certified by the All India Council for Technical Education, has an approved capacity of 30 students per batch. The following are the activity highlights of CHM during 2010–11.

### Student Profile (On-going Batches)

#### Batch IV

Batch IV (2009–11) consists of 29 students. At the time of joining the PGDHM programme, about 31 per cent and 21 per cent of the students of Batch IV were graduates in medical and paramedical disciplines, respectively. About 45 per cent of the students were graduates or post-graduates in various science disciplines, while 3 per cent possessed other qualifications.

#### Batch V

In the fifth batch (2010–12), 30 students were enrolled. At the time of joining the PGDHM programme, about 27 per cent and 26 per cent of the students of Batch V were graduates in medical/paramedical disciplines and graduates in alternative systems of medicine, respectively. About 34 per cent of the students were graduates or post-graduates in various science and engineering/technology disciplines, while 13 per cent possessed other qualifications, including bachelors in Hospital Management.

#### **Academics**

The PGDHM programme is conducted over four semesters, including three semesters of classroom teaching, practicals and fieldwork, a two-month summer project, and one semester of internship at healthcare institutions. ASCI faculty and guest faculty, including industry professionals, deliver sessions for the PGDHM programme modules.

During the year under review, the students of Batch III (2008-10) completed their fourth semester internship and dissertation requirements. Final viva-voce sessions were conducted in May 2010. They also received their diplomas at the convocation held in October 2010.

At the close of 2010–11, all the 29 students of Batch IV had completed the academic requirements of the programme and were pursuing their final semester internships at various healthcare organizations in the country.

During the year under review, students of Batch V completed their first semester. At the close of 2010–11, teaching was in progress for the second semester.

# Final Semester Internships and Placements for PGDHM Batch IV (2009-11)

The Centre for Healthcare Management made vigorous efforts to secure both fourth semester internships and final placements for the students of Batch IV. Following the release of the PGDHM Placement brochure on the 23 October 2010, the Centre organized a 10-day placement event in December 2010, involving on-site interviews as well as telephonic interviews.

As a result of the Centre's placement efforts, all the 28 students of Batch IV who sought placement assistance received placement offers. One student opted to pursue further studies and did not seek placement assistance. The offers were received from organizations across the country working in the core healthcare sector, as well as in healthcare consulting and healthcare IT services. Organizations that made placement offers to four or more students include Infosys, Wockhardt Hospitals and Medica Synergie. Others that made placement offers included Ascelepius, ICICI Lombard, 21st Century Health Management Solutions, Mediciti Hospital, Fernandes Hospitals, Fortis-Escorts Hospital, and Medanta—The Medicity.

Internships with leading organizations in the healthcare sector were obtained for all the 29 students of Batch IV for their final semester.

#### Notes forming part of the Accounts

- 1. Contingent liabilities not provided for:
  - (a) Guarantees given by banks on behalf of the College outstanding as on 31.03.2011: Rs. 8,028,836: (31.03.2010: Rs. 2,494,771).
  - (b) Claims against the college not acknowledged as liability as on 31.03.2011: Rs. 494,639.
- 2. In terms of Notification No. 74/2007, dated. 23.03.2007, issued by the Central Government, the College's income is exempted from tax and hence, in the accounts, no provision for income tax has been made.
- 3. The unsecured loan of Rs. 5 crores from the Government of India was received on the following terms:
  - a) The loan is repayable after a period of five years from the date of disbursement (i.e. 05.04.2007) in 10 equal annual installments of Rs. 50 lakhs each.
  - b) The College may invest any unutilized money from the loan amount in Government Securities or in fixed deposits in any of the nationalized banks or public sector enterprises. As on 31 March, 2011, the unutilized amount and interest thereon aggregating to Rs. 35,115,570 has been invested in fixed deposits with State Bank of Hyderabad.
- 4. As per the decision of Court of Governors, debts outstanding for more than one year are considered as doubtful debts and have been provided for.

#### 5. **Gratuity:**

The College formed the "ASCI Employees Gratuity Trust" for the purposes of funding the liability attributable to Gratuity. The trust, in turn, has taken a policy with Life Insurance Corporation of India under the LIC's Group Gratuity Scheme ("the Scheme").

The gratuity liability as at 31 March 2011 has been actuarially determined at Rs. 55,402,777 after taking into consideration the plan assets of Rs. 55,134,888, which represents amounts funded by the trustees with Life Insurance Corporation of India. The balance liability of Rs. 267,889 has been accounted for and reflected in the accounts as provision for gratuity to employees.

#### Leave:

The College has taken Group Leave Encashment policy with LIC for providing leave encashment benefits under the LIC's "Employees Group Leave Encashment-cum-Life Assurance (Cash Accumulation) Scheme" ("the Scheme").

The leave liability as at 31 March 2011 has been actuarially determined at Rs. 41,879,122 after taking into consideration the plan assets of Rs. 35,182,628, which represents amounts funded by the College with Life Insurance Corporation of India. The balance liability of Rs. 6,696,494 has been accounted for and reflected in the accounts as provision for leave liability.

- 6. Gain on sale of investments represent the profit on sale of Units of CRTS.
- 7. In terms of an arrangement with the CIPS (Centre for Innovations in Public Systems), the College has charged Rs. 1,600,000 towards annual base charge and Rs. 1,800,000 towards infrastructure, administration and general charges during the year 2010–2011. These amounts, aggregating to Rs. 3,400,000, are included under other income in Schedule 3 of the financial statements.
- 8. Figures for the previous year have been regrouped wherever necessary.

### 9. SIGNIFICANT ACCOUNTING POLICIES

(i). All revenues, costs, assets and liabilities are accounted for on an accrual basis.

### (ii). Revenue Recognition

- a) Income from Short Term Management Development Programmes, Seminars and In-Company Programmes is recognized on substantial completion basis. Income from Long Term Management Development Programmes is recognized on proportionate completion basis.
- b) Income from Research and Management Studies is recognized on proportionate completion basis. Income, other than from Research Studies, excludes recovery of expenses.
- c) The operational income from Management Development Programmes and Research and Management Studies are net of service tax wherever applicable.
- d) Income from Investments includes income from Investments of Endowed Chairs, but excludes unutilized income carried forward where there is stipulation to that effect.

### (iii). Gratuity and Leave Liability

Provision for Gratuity and Leave encashment is made on the basis of actuarial valuation, and the same is partly funded with Life Insurance Corporation of India.

### (iv). Depreciation

Depreciation is provided on the straight-line method (SLM) at rates based on the estimated useful life of assets as given below. No depreciation is charged on leasehold land.

Assets costing less than Rs. 5000, except Library Books, have been fully charged to the Income and Expenditure Account.

### (v). Foreign Currency Transactions

Monetary assets and liabilities are not restated at year end, and consequently the resultant foreign exchange gains/losses are not recognized.

### (vi). Fixed Assets

Fixed Assets are stated at their original cost of acquisition, including all expenses attributable to bringing the assets to their intended use. Assets acquired out of the grant from Government of India towards Computer Aided Management Centre, ownership whereof vests in the Department of Electronics, Government of India, are capitalized with corresponding credit to Corpus Fund, and depreciation thereon is charged at rates adopted by the College.

### (vii). Investments

Investments are stated (a) Long Term Investment 'at cost', provision is made to recognize a diminution, other than the temporary in the value of such investments and (b) Current Investments 'at lower of cost and fair value'.

### (viii). Inventories

Inventories are valued at cost on a First in-First out (FIFO) basis.
