Programme Overview

This three-day programme on Government e-Marketplace (GeM) and e-Procurement is designed to provide **comprehensive exposure to GeM**. At the same time, the programme will also **familiarize participants with the Central Public Procurement Portal (CPPP)**. Participants will gain in-depth knowledge of the various usability features of GeM and learn how to use CPPP. The programme will also feature **good practices presentations and success stories** from experienced GeM users, offering valuable real-world examples. Additionally, **dedicated Q&A sessions** will address participants' queries, ensuring they are equipped with **practical skills** and insights to navigate and utilize these platforms effectively and maximize value for their organizations.
