## Programme on Climate Tech Innovations - A Sustainability Pathway for Energy Sector (January 20 – 22, 2025)

Globally, the energy sector has seen the highest push for transition to cleaner alternatives through policies, regulations and investor mandates. This is because, energy sector (that includes energy generation and energy use sub-sectors like transport, industry etc.), contributes to over 70% of GHG emissions globally. To effectively transition, it is essential for leaders and executives from energy sector (and energy use sub-sectors such as industry), to understand various aspects that are driving this transition. These include Environment, Climate Change, Regulatory as well as Socio and Techno-economic aspects. For organizations and industries, policies, mandates, ESG frameworks, SBTi framework, Carbon regulations and Sustainability reporting requirements, are the biggest drivers in this transition. For example, the Carbon Credits Trading Scheme (CCTS) announced in June 2023 and the Indian Carbon markets, would mandate emission reduction in high emitting sectors notified as designated consumers like Aluminum, Cement, Chor Alkali, Iron and steel, Fertilizers, including DISCOMS and other sectors.

#### **PROGRAMME OVERVIEW**

Climate Technology (Climate Tech) innovations are increasingly becoming the top most funded technologies globally including India across funding stages. There is increasing participation of Corporate Venture Capital and / or corporate grants for R&D, Prototyping, Pilots or Early Commercial Stage demonstrations.
